HR Services continues to contract out more jobs. As of March 7 there will be no more AA retirement councilors available to members for one on one exit interviews; this will all be handled by Mercer through phone and internet.

TWU Employees and retirees will begin using the new retirement tools and services immediately. American has introduced a new pension calculator within the Benefits Service Center on Jetnet and revamped retirement services for domestic AA employees. These changes continue Human Resources' efforts to improve the tools used by employees and retirees.
