AA Bankruptcy Update

TWU Bargaining Units Meet in Dallas to Negotiate "Me-Too" Clauses with AMR

The five TWU-Represented Bargaining Units (Fleet Service Clerks, Dispatchers, Ground School Instructors, Maintenance Control Technicians, and Simulator Technicians) that accepted American Airlines offer last month will negotiate improvements as a result of more favorable terms offered to Pilots. Following "Me-Too" talks, Maintenance and Stores workers seek to meet with Company negotiators.

The May offers included "me-too" clauses that stated that any further improvements in valuation or profit sharing received by other work groups would be extended to bargaining units that consented to accept the Company offers. These so-called "me-too" clauses became active when AMR improved its offer to the Pilots union last week.

Plans to restart negotiations for the two TWU work groups that did not accept earlier offers has been communicated to AMR. Negotiators for the Maintenance and Stores bargaining units are expected to meet with the Company after the "me-too" talks conclude.

TWU Survey

Many members have received phone calls inquiring about union representation and other aspects of your job. We had just learned that the TWU International signed a contract with the Hart Research Group to do a survey with our members. We did a similar survey in 2003. The TWU International has since made it a policy when there are representation drives in progress, they do a survey in order to find out where we need to improve and how we should go forward with better representation. Please take the time to answer the questions if you receive a call from Hart.

Proof of Claim Forms

Recently, everyone received a Proof of Claim Form from American Airlines. Many questions have come up about this form like "Who should fill out the form? or How do you fill out the claim form?" We have received a response from our legal team. They told us that if you feel that you have a claim against American Airlines you should file a claim. Some examples of those claims could be: Stocks, grievances, workers compensation, medical claims, etc. Anything you may think American Airlines may owe you money for is a good way to know if you should make a claim. If you have lost the forms or need guidance on filling the forms out please go to the TWU Union Hall on Pine or the Grievance Office in the Palm building.
