Important Deadlines

Benefits Enrollment Ends October 31

You can't wait any longer. Changes to the AA benefits are major this year. Complete your enrollment and print off your final selection. The printed document of benefits may save you a lot of headaches next year.

<u>Get Secure Flight Ready - What Do I Do?</u>

Verify that your name and your guest travelers' names in Jetnet's "Traveler Information" matches the valid government-issued ID you use for travel The deadline to change names is **Oct 31**. Go to Jetnet's Travel page for more information and instructions.

Tulsa Oilers Ticket Vouchers are available at the Union Hall. The next game is Oct. 31. You may redeem the voucher at the main Oilers' office or at the BOK center at the TWU table in front of the ticket windows.

November 2nd Election Day

It is time for you to make your voice heard. Absentee and Early voting is highly recommended. Contact your county election board for more details on absentee and early in-person voting. If you haven't seen the TWU endorsement list, ask your shop steward to pick one up from the Grievance Office or Union Hall.

Save Your Training Records Before Next Year

The transfer of training records to LMS (in Jetnet) for all M&E employees will be completed during the first quarter of 2011. At that time, training records will be removed from Sabre. It is strongly recommended that employees access and copy training records before this date to protect yourself in the event that data is lost during the transfer. Training records can be accessed in Res by signing in and then typing MQ*employee number/A enter, or JJemployee number/A enter. If your Res code has expired, see your staff assistant or supervisor to reinstate. (Training)

Flexible Spending Accounts (FSA) Debit Cards will be 'Turned Off' January 1, 2011

The Health Care FSA debit card will be turned off effective January 1, 2011. You can still access your 2010 Health Care FSA dollars through the grace period of March 15, 2011 by using Express Online or auto reimbursement. There are other changes too. Effective January 1, 2011, over-the-counter (OTC) drugs will no longer be reimbursed without a prescription. Take a few minutes to learn more on the Enrollment Planning page on Jetnet. FSAs are a great way to save on your taxes but you have to enroll each year. Benefits enrollment ends at midnight Central time October 31, 2010. Its main purpose is to ensure all work being performed by our TWU brothers and sisters for AA operations continues to be done in-house. The policy of the RO Committee is that the work should be done at one of AA's overhaul facilities rather than an outside vendor.

Outsourcing cuts into our workforce and makes us all vulnerable to downturns in the economy and world events that affect our industry. The RO Committee is doing everything in its power to ensure that our airline survives and our jobs are secure.
