# TWU 514 Smoker Policy & Usage Agreement

## Local 514 Smoker Reservations Policy

When the TWU Smoker is not otherwise in use, it may be reserved by Local 514 members only who are in good standing and by organizations that promote the objectives of organized labor; provided, however, that the member must be in good standing and have attended at least two (2) membership meetings within 12 months preceding the event.

- **RESERVATIONS:** Reservations must be made at the TWU Local 514 Office.
- **FEES:** A \$150 cashier's check or money order shall be required for deposit. The deposit shall be refunded upon return of the gauges, less any charges for repairs, damages, late fees or cleaning, if any. The smoker must be returned clean and in a timely manner.
- **RETURN:** The User is responsible for contacting the office to make arrangements for return of the smoker and gauges. Any Special arrangements must be done so in writing prior to
- **Late Return Fee:** If the smoker is used past the pre authorized "Usage Dates" from page one (1) of this agreement, there will be a \$50 per day penalty applied and may restrict future User usage.

Use of the smokers is a privilege and the responsibility for their care and maintenance belongs to all of us.
