**THIRD AMENDED JOINT STIPULATION
AND SCHEDULING AGREEMENT AS TO FILING AND
HEARING OF PLAINTIFFS-DEBTORS' PARTIAL SUMMARY
JUDGMENT MOTION IN THE ADVERSARY PROCEEDING**
