ARTICLE XI – Sections

- a. There shall be a ~~Stores~~**Material Logistic Specialist** Section, an **Aircraft** Maintenance Section, a Maintenance Control Technician Section, and a Facilities/GSE Maintenance Section. Each section shall have a chairman who shall be elected by members of their respective sections during the general elections of Officers. ~~The elected chairman from the largest section as stated herein shall serve on the Local 514 Negotiating Committee; provided, however, that in the event the chairman from the largest section is from the same contract group as the Local 514 President, then the Chairman of the second largest section shall serve on the Local 514 Negotiating Committee.~~
- b. Section Chairs shall keep the President and the Executive Board advised of the functions of their respective Sections.**
- ~~b- c.~~ **c.** GSW shall be under the jurisdiction of Local 514 and considered to be a “down line” station and shall hold regular monthly membership meetings.
- ~~e-d.~~ **d.** GSW shall have station Officers of Vice Chairman and Recording Secretary positions, that shall be elected by members represented at that station and shall be elected in accordance with Article VIII.
- ~~e.~~ ~~All applicable provisions of these Bylaws will apply equally to all Stations under the jurisdiction of Local 514.~~
- ~~d.~~ ~~Section Chairs shall keep the President and the Executive Board advised of the functions of their respective Sections.~~
- e. The Station Vice Chairperson and Recording Secretary shall assist the Chairperson and carry out such other duties as may be assigned to him by the Chair, Executive Board or President.
- f. All applicable provisions of these Bylaws will apply equally to all Stations under the jurisdiction of Local 514.**
